The company has delivered the following benefits to GP practices and people in Salford.

- We've increased the number of qualified Advanced Practitioners in Salford to 12 with 13 currently in training. We are on track to bring an extra 25 APs into Salford. We've also recruited four GP Fellows, bringing extra GPs into Salford. Both these measure will make it easier for local people to get a GP appointment.
- We delivered training for 30 Health Care Assistants, bringing extra skill and capacity to 28 GP practices
- We delivered training to a total of 558 members of practice staff to 40 of our training courses, improving the skills and service to local people.
- Through our extended access programme, 8,853 extra appointments were made available for practices across Salford to offer their patients on an evening or weekend.
- Established a GP service in the local hospitals A&E department so people can gain more rapid access to appropriate medical help
- We have worked with Salford Care Organisation, Greater Manchester Mental Health Trust and Salford VCSE sector to set up a multidisciplary team to provide better joined up care to people with complex health issues in 2 neighbourhoods in Salford
- The Primary Care Diagnostic Unit in Ordsall & Claremont neighbourhood has seen nearly 900
 patients, with easy and convenient access to diagnostics tests.
- Our GP Acute Home Visiting Services for housebound people have offered around 1,500 appointments at patients' homes.
- We have delivered Care navigation training to 220, practice staff who are better able to support
 patients to explore alternative safe, appropriate options
- Supported a group of practices to hold a Christmas event for older people to help them socialise
- We have brought together 43 GP practices into 5 neighbourhood teams, looking at improved patient care and more effective and efficient use of shared resources
