We are a Primary Care and GP support organisation, and are a Social Enterprise that is independent of but strongly aligned to the principles and values of the NHS, working for the benefit of local people and communities.

In the last financial year we started to re-focus our work and to develop services that customers and commissioners wanted to buy that added value and took strain out of the system. During the financial year we began the process of bringing in three new GP practices, the GP homeless service and its 60 plus staff members into the fold!

We were delighted with the extra faces, and the acquisition of the new practices gave us greater capacity and capability, which in turn benefits the rest of primary care in Salford which we exist to serve. We also worked hard to reduce and remove barriers between primary care, community services, mental health care, social care and hospitals. We built new teams like the Enhanced Care Teams, tested new ways of working within general practice, provided services like the Salford Wide Extended Access Pilot and delivered the education and training programmes.

We worked with the eleven practices in Little Hulton and Walkden to hold the Wellbeing Festival, which welcomed over one thousand local people. With money from our Innovation Funding programme, we've provided the platform for a number of great schemes and events to take shape, for example:

- Practices in the Ordsall and Claremont neighbourhood have been holding parties and events for local residents to try and combat social isolation
- A high-profile scheme got underway at the new Royal Horticultural Society (RHS) Garden
 Bridgewater in Salford to provide social prescribing for eligible residents
 We were also able to facilitate the securing of GM Pension fund monies to enable the work of many others over the last ten years to bring the Little Hulton Health Centre development scheme to life with the final deal being closed in the current year, so more of this to come
